PUBLIC NOTICE No. 05/2012 Dated the 6th of December 2013

Subject: Procedure to be followed for granting Permission of Factory Stuffing (LoFSP) to manufacturer-exporters, merchant-exporters-reg.

Attention of the Exporters, CHAs and the Public is invited to the Board's Circular No 20/2010-Customs dated 22.07.2010 wherein it has been provided that in order to reduce the transaction cost, a single factory stuffing permission shall be granted which shall be valid for all Customs stations from where the exporter proposes to export goods. However, in this regard the Board has also prescribed certain safeguards to be followed while granting Single Letter of Factory Permission which will be valid for all Customs Ports. In this connection, the Technical Branch, Customs Hqrs, Shillong will process all requests received for Factory Stuffing Permission.

- 2. The Hqrs. Technical Branch, herein after will issue LoFSP (Letter of Factory Stuffmg Permission) in the format as annexed to this Public Notice (Annexure'A') to the categories of exporters mentioned below subject to the requirements detailed therein and thereof.
- 3. In terms of Board's Circular No 860/18/2007-CX dated 22.11.2007, self-sealing of export of goods has been made mandatory for the manufacturer exporters (whether status holder or not) who export such goods under free shipping bills where no export benefit are being sought. Therefore, LoFSP will not be granted to the manufacturer-exporters in respect of exports under free shipping bills. However, they can opt for factory stuffing of export goods under export

incentive schemes.

- 4. In case of non-status holder manufacturer exporters operating under any export incentive schemes (i.e. in case of exports other than under free shipping bills), the LoFSP will be granted only on receipt of prior verification report regarding the genuiness of the existence and functioning of the manufacturing units and the No Objection Certificate from the concerned jurisdictional Central Excise Authorities regarding deputing of the officers for supervising the export stuffing operations. The genuineness of the IEC will also be confirmed from DGFT website before issue of LoFSP.
- 5. Similarly, in case of non -status holder merchant exporter the LoFSP will be granted only on receipt of prior verification report regarding the genuineness of the existence and functioning of the their warehouses/supporting manufacturer's units and No Objection Certificate from the concerned jurisdictional Central Excise Authorities regarding deputing of officers for supervising the export stuffing. The genuineness of the IEC of the exporter will also be confirmed from DGFT website before issue of LoFSP.
- 6. In case of status-holder merchant and manufacturer-exporters, the LoFSP will be granted provisionally which will be valid for 30 days and within such period the verification reports i.e. NOC from the concerned jurisdictional Central Excise Authorities regarding deputing of officers for supervising the export stuffing and verification report regarding the genuineness of the existence and functioning of the unit shall be submitted by them failing which the permission will stand automatically cancelled. On receipt of the verification report and acceptance of the same by the Deputy Commissioner (Tech), endorsement by Superintendent (Tech) regarding the same will be made on the Original LoFSP.
- 7. Though the LoFSP granted to manufacturer -exporters and other category of exporters is one time permission in nature, their track record will be monitored and reviewed periodically from the Central Excise Authorities and other custom stations i.e. after a period of every six months. The LoFSP will be liable to be cancelled in cases where the verification report received from Central Excise Authorities or other Customs stations is adverse and / or the exporters are facing any proceedings under

Customs, Excise, Service Tax or any other allied Acts.

- 8. All the exporters who seek factory stuffing permission shall submit their request for factory stuffing along with the details as given in Performa annexed as Annexure -B to the Deputy Commissioner (Technical), Customs Hqrs, Shillong. The exporter shall fill all the details in the annexure 'B' and write "Not Applicable" if any of the field does not pertain to them. The exporter shall also furnish a list of customs stations from where he intends to export his goods and also inform if they have applied to any other Custom House for LoFSP and status of the same. The following documents should also be submitted along with the request application:
 - i) NOC issued by Central Excise Authorities for deputing officers for supervising the factory stuffing of the export cargo. This NOC will be required to be under the signature of Deputy/Assistant Commissioner or above.
 - Duly filled in Annexure-B. This will then be forwarded by Customs to the concerned Central Excise Authorities for verification. The genuineness of the existence and functioning of the factory will be verified by the Central Excise Authorities. The verification report must be under the signature of Deputy/Assistant Commissioner or above. In case of merchant exporter, verification report from jurisdictional Central Excise office informing of the existence of Registered Office address, is must.
 - iii) Copy of the IEC issued by DGFT duly authenticated by the exporter himself/herself.
 - iv) Copy of the PAN card duly authenticated by the exporter himself/herself.
 - v) Copy of the Status House certificate duly authenticated by the exporter himself/herself.
 - vi) Copy of the audited Balance Sheet for last Financial Year duly authenticated by the exporter himself/herself.
 - vii) Details of authorised signatories alongwith their specimen signatures as per Annexure –C in duplicate.
- 9. The Hqrs. Technical Branch upon receipt of the complete application along with the said documents, will cross check the genuineness of the details furnished in the sealed cover from the jurisdictional AC/DC of Central Excise telephonically, by fax or by Email. The genuineness of the IEC shall also be checked from DGFT website. The

LoFSP shall be granted to the exporter within seven working days of receipt of verification report from Central Excise Authorities in the format Annexure 'A'. All the permissions shall be given a unique running serial number for each of such permissions granting the factory stuffing permission.

- 10. The Hqrs. Technical Branch shall maintain a register to keep a track-record of such permissions. The factory stuffing permission letter shall be circulated to all the customs houses for which the permission has been sought by the exporter along with a copy of the Annexure-'B' and Annexure-'C'. The Annexure-'B' contains the name and contact details of the Central Excise Range/Division concerned to facilitate real time verifications by the custom house, if required.
- 11. The Exporters clearing goods under the Factory Stuffing Permission shall produce, at the time of goods registration, a copy of the LoFSP self attested along with the ARE-I and other relevant documents. The goods registering Officers posted in the Export Shed will cross check the validity of Factory Stuffing Permission as to whether it is valid or the permission has been revoked.
- 12. The Exporters clearing goods under the Factory Stuffed Permission shall ensure that the containers are sealed by One Time Bottle Seal and mark the number only. In case, it is found that the containers are not sealed by one time bottle seal or if the seal is broken, the AC / DC (Export shed) shall get the goods examined as if these were not covered under the Factory Stuffing Permission.
- 13. The Central Excise officer who supervised the examination and stuffing of the cargo in the appointed premises as per the LoFSP shall mention his office contact Number and put his stamp of name and designation in the examination report / ARE-I and other documents. Similarly, the contact number, name, designation of the authorized signatory of the exporter also will be legibly indicated below his signature in the ARE-I that accompanies the export goods. The Central Excise officer who supervises the examination and stuffing of the cargo should ensure that the container is sealed by one time bottle seal and he should mention the one time bottle seal no. in his examination report.

- 14. Details of LoFSP issued by this Commissionerate shall also be listed in the website of this office (www.shillongcustoms.nic.in), which can be used for verification of the LoFSP.
- 15. In case of LoFSP issued by other Customs House which is valid for exports through stations in this Commissionerate, the exporter/CHA shall produce the copy to Technical Branch, Customs Hqrs., Shillong and first time it will be verified for its authenticity from the issuing Customs House by FAX/Regd. Post. After verification, a separate letter of verification shall be issued which would be valid for all subsequent export clearances through this Commissionerate.
- 14. Any difficulty experienced in the implementation of this Public Notice may be brought to the notice of the undersigned immediately.

3. The permission is valid subject to following conditions:

- i. The exporter shall ensure that all the factory stuffed containers are sealed by one time bottle seal and not by any other means.
- ii. No correction/changes/amendment in the LoFSP will be valid unless the request for any correction/change/amendment is applied for and approved by the competent authority.
- iii. This LoFSP shall remain valid till the permission holder carries on the activity for which it has been issued or surrenders it or till it is revoked/suspended by the competent authority. However, if no exports take place in the jurisdiction of this Commissionerate for a period of six months; the permission should be liable to be cancelled on this ground alone.
- iv. The exporter shall provide necessary assistance & co-operation as may be required by the Central Excise authorities for carrying out the examination norms laid down from time to time. The permission is however subject to any examination by Customs.
- v. This LoFSP is valid only for exports other than those being exported under free shipping bills.
- vi. The exporter shall present the goods alongwith the processed shipping bills or check list of shipping bill with relevant invoice (in quadruplicate for export under drawback claim and in triplicate for the goods under any other scheme), packing lists and G.R. Form/Export Declaration Form etc. with a written request to the jurisdictional Superintendent of Central Excise.
