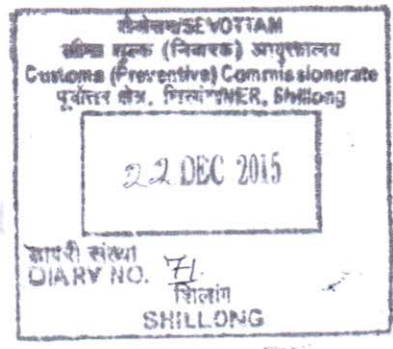

1. Representations have been made by M/s Dhar Mining Company Pvt. Ltd/ M/s K Singh Wann & Sons, Bholaganja, East Khasi Hills, Meghalaya seeking Amendment to the Notification **No 45/2010**-Customs (N.T) dated 4th June, 2010, Serial No 23(g) to add "Sonai Road" for export of limestone to Bangladesh.
What actions have been taken in this regard by the Ministry and copies of the Note sheets / orders in this regard may kindly be provided.
