- (1) Dates of sale of Dry Betel Nuts sold in Public Auction/ E-Auction in the whole of the jurisdiction of the Customs (Preventive) Commissionerate, Shillong during the year 2015-16.
- (2) Auction date-wise quantity, seizure value, market value and Auction sale prices of Dry Betel Nuts sold in Public Auction/ E-Auction in the whole of the jurisdiction of the Customs (Preventive) Commissionerate, Shillong during the year 2015-16.
- (3) Whether Tests/ chemical analysis conducted, if any, to ascertain whether the seized Dry Betel Nuts were fit for human consumption before being sold in Public Auction/ E-Auction in the whole of the jurisdiction of the Customs (Preventive) Commissionerate, Shillong during the year 2015-16 and, if so, the dates of such Test Reports, Authority (s) conducted such tests, findings/ results of such tests.

(4) Date(s) of destruction, quantity and value of the seized Betel Nuts including Dry Betel Nuts sold in Public Auction/ E-Auction in the whole of the jurisdiction of the Customs (Preventive) Commissionerate, Shillong during the year 2015-16, which were found on Test/ chemical analysis to be unfit for human consumption and, if not, the reasons thereof.

(5). Auction date-wise names and addresses of the successful bidders, quantity purchased and auction sale proceeds, who purchased the seized Dry Betel Nuts sold in Public Auction/ E-Auction in the whole of the jurisdiction of the Customs (Preventive) Commissionerate, Shillong during the year 2015-16.

5. I hereby inform that following formalities have been completed by me:
