Please refer to your application dated 22-02-2016 addressed to the Shri Bimal Kumar, Under Secretary, Room No. 332, Vigyan Bhavan Annexe, New Delhi-110011 received to this office on 07.04.2016 on transfer under Section 6(3) of the RTI Act, 2005.

The point wise reply in respect of jurisdiction of the Customs Division, Agartala are furnished as under;

1. There are four Nos. of functional LCSs, viz. (i) LCS, Agartala, (ii) LCS, Srimantapur, (iii) LCS, Muhurighat & (iv) LCS, Khowaighat and two Nos. of non-functional LCSs viz.(i) LCS, Dhalaighat & (ii) LCS, Sabroom under the jurisdiction of the Customs Division, Agartala.
2. There is no such list of goods available in this Office that can be traded at land borders with Myanmar, China and Bangladesh. However, the goods in Schedule 1 & II of the Customs Tariff Act, 1975 which are not prohibited, restricted and having no any Non Tariff barrier (NTB) can be traded through the LCSs under this Division.
3. In the F. Year 2015-16 (Upto February, 2016) Goods of value Rs.336,40,51,741/- Imported and Goods of value Rs. 59,53,406/- Exported.
4. Information on State-wise status of Food testing laboratory for LCS in the NE India is not available at this Office.
5. Information regarding functioning of the Kaladan Multi-model Transit Transport Project is not available at this Office.
6. Information not available at this Office.


