- (i) The vehicles can be inspected between 11.00 am and 5.00 pm on 6th and 7th August, 2015.
- (ii) Closing date & time for receipt of bid: 5.00 pm on 08.08.2015.
- (iii) Place for submitting bid: Tender Box kept at O/o The Commissioner of Customs (Preventive), NER, Shillong. The separate cover for each vehicle should be prominently super-scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE REGISTRATION NUMBER
- (iv) Bid Opening Date & Time: 10.08.2015 at 11.00 am.
- (v) Place of Bid Opening: In the Room of Additional Commissioner, Customs Hqrs Office, Shillong.

Note:

- (i) Bids shall be opened on the date/time as indicated above in the presence of the bidders or their representatives who may wish to be present.
- (ii) Bids received after the specified date and time will not be considered.
- (iii) The possession of vehicle would be handed over to the bidder who has give/quoted highest bid/value of the each vehicle.
- (iv) The successful bidder shall deposit the bid amount within two days from the acceptance of tender. The successful bidder has to remove the vehicle at his own cost within three days of final payment, failing which resale of the vehicles will be undertaken at the risk and cost of the defaulters.
- (v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters Identity Card in case of individual and registration certificate in case of firms etc.).
