As desired the point wise information are furnished below.

1. Proof of prevention of animal smuggling and its details are mentioned in Sl. No. 3.
2. Already replied.
3. Cattle seized by the BSF in border areas for the last three years are as below.

4. All the cattle seized were auctioned by the Customs authorities as these are the highly perishable livestock.
5. No cases of abuse of seized cattle reported.
6. Not related to customs.
7. No complaint received so far.
8. No complaint of corruption received against Customs Officer.
9. No. such registry available.
10. Revenue earned by this office has been given above in Column No. 4 of Point No. 3.

11. Source of supply of animal for smuggling is not known, however, it is found that most of the cattle seized are of local breed from Bengal and Assam.
12. Cattle smuggling is tried to be controlled by effecting seizure for attempting to be exported illegally by the BSF and the Customs and by enforcing the PCA Act, 1960 by the State Govt. Authorities.
13. All the smugglers caught at the time of exportation are handed over to the State Police authorities for legal proceedings.
14. Already replied.
