Please refer to your application dated 06.12.2016 on the above subject.

As desired the point wise information are furnished below.

1. Auction of cattle was conducted on 18.07.2016 whereas, as per your submitted documents 5(five) nos. of cattle died on 19.07.16. Moreover, death certificate of cattle is issued by a veterinary doctor only.

2. Total no. of cattle auctioned in the Anti-Smuggling unit during the month of Oct/2016 was 1221 no. and 72 no. of TR-5 was issued against those auctions. Rs. 148/ (72x2) is to be deposited for furnishing copy of TR-5. Since information of bidder is a third party information so the same can not be provided as per Section 11 of RTI Act, 2005.

3. Fees yet to be deposited.

Auction sale are conducted at all locations ~~whether Dhubri or Haldiyganj~~ on the condition "as they are, where they are". The whole lot or lots shall be taken from the site with all faults and errors in description or otherwise and no warrantee or guarantee shall be implied. The goods are sold on the assumption that the bidders have inspected the lots and know what they are buying whether they have inspected or not. The principle of Caveat emptor will apply and no complaint will be entertained. Thus auctions are held on the basic guidelines as per Manual of Departmental instructions on Adjudication.(Refer to Chapter II Para 8E). There is no regulation / instruction under Customs Act to conduct auction at the site / spot where the seized goods are kept.
