ORDER

Dated, Shillong, the 11th August, 2014

Shri Lamkhogin Kipgen, Inspector was appointed as Assistant (CCS) in the Ministry of Urban Development, New Delhi on 13.12.2012 and his pay has been fixed at Rs. 12540/- with Grade Pay of Rs. 4600/- (PB-2, Rs. 9300-34800 + 4600/-) w.e.f. 13.12.2012 before earning increment and at Rs. 13060 + 4600/- after earning increment on 08.07.2013 (since he joined CPWD, Shillong on 08.07.2013, on being transferred from MOUD, New Delhi, after availing 13 days joining time). On being appointed as Inspector in this Office, he joined on 30.06.2014(A/N) and his pay has been fixed at Rs. 12540/- with Grade Pay of Rs. 4600/- (PB-2, Rs. 9300-34800 + 4600/-) w.e.f. 01.07.2014.

Since counting of past service rendered by Shri Lamkhogin Kipgen, Inspector, Customs (Prev.) Commissionerate, N.E.R., Shillong as Tax Assistant in the O/o the Commissioner, Central Excise & Service Tax, Shillong from 21.09.2010 to 11.12.2012 and w.e.f. 13.12.2012 to 30.06.2014 as Assistant (CCS) in MOUD, New Delhi & in the O/o the Chief Engineer(NEZ-I), CPWD, Shillong has been approved by the Commissioner of Customs (Prev.), N.E.R., Shillong vide Order dated 11.08.2014, he is therefore, eligible to pay protection as per FR 22(I)(a)(1) on the basis of the last pay drawn by him as Assistant (CSS) in the CPWD office, Shillong which is Rs. 13060 + 4600/-.

In view of above, the Commissioner of Customs (Prev.), N.E.R., Shillong has been pleased to re-fix the pay Shri Lamkhogin Kipgen, Inspector at Rs. 13590 + 4600/- w.e.f. 01.07.2014 with DNI on 01.07.2015.
