#### B. Time Schedule

- (i) The vehicle can be inspected between 11.00 am and 5.00 pm on 24<sup>th</sup> April, 2017.
- (ii) Closing date & time for receipt of bid: 05.00 pm on 24.04.2017.
- (iii) Place for submitting bid: Tender Box kept at O/o The Commissioner of Customs (Preventive), NER, Shillong. The separate cover for each vehicle should be prominently super-scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE REGISTRATION No. ML-05-B-0839".
- (iv) Bid Opening Date & Time: 25.04.2016 at 1 PM.
- (v) Place of Bid Opening: In the Conference Room of O/o The Commissioner, Customs Hqrs Office, Shillong.

#### Note:

- (i) Bids shall be opened on the date/time as indicated above in the presence of the bidders or their representatives who may wish to be present.
- (ii) Bids received after the specified date and time will not be considered.
- (iii) The possession of vehicle would be handed over to the bidder who has quoted highest value of the vehicle.
- (iv) The Bidder shall deposit Earnest Money Deposit (EMD) of Rs. 5,000/- (Rupees Five Thousand) only in favour of the Department. In case, the successful bidder fail to deposit the bid amount within the stipulated period of time or on surrendering the Bid the said amount will be forfeited.
- (iv) The successful bidder shall deposit the bid amount within 24 hrs from the acceptance of his bid. The successful bidder has to remove the vehicle at his own cost within two days of final payment.
- (v) If the successful bidder failed to deposit the money within the stipulated time, the next highest bidder would be considered for acceptance if it exceeds the Reserved Price of the vehicle fixed by the Committee.
- (vi)The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters Identity Card in case of individual and registration certificate in case of firms etc.).
- (vii) All taxes/levies etc. will be borne by the buyer over and above the bid price.
- (viii) The vehicle will be sold on "AS IS WHERE IS BASIS" and no guarantee for its worthiness or quality will be given by this Department.
- (ix) The Commissioner of Customs (Preventive), NER, Shillong reserves the right to reject any or all quotations without giving any reason.
