1. The Departmental Auction Committee reserves the right of fixing the 'Reserve Price' of the goods being sold. The goods will be sold to the highest bidder among the bids received through sealed tenders, provided the highest bid is equal to or more than the 'Reserve Price'.
2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
3. The successful bidder has to deposit 25% of the Bid Amount as 'Earnest Money' immediately within 24 hrs after completion of the auction. The 'Earnest Money' of the person(s) withdrawing/cancelling their offer after submitting their bid shall stand forfeited.


If desired, the tenderers may be present at the venue when the sealed tenders are opened.


