The whole procedure of valuation is done in terms of Section 14 the Customs Act, 1962 read with Customs valuation (Determination of value of Imported goods) rules 2007. In this matter Director General Of Valuation's alert notice/rate etc. circulated time to time are also followed. For the rate fo customs duty Indian Customs Tariff and Notifications relating to same is to be followed.
