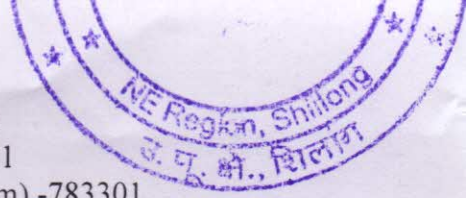

Please refer to your application No. CBECE/R/2017/50235 dated 21.02.2017 and subsequent RTI Appeal application No. CBECE/A/2017/60069 dated 26.04.2017 received by this office on 19.06.2017 transferred under Section 6(3) of the RTI Act, 2005 by the CPIO, Customs (Prev.), Hqrs., N.E.R., Shillong.

As desired, the information are furnished as under-

Where a person is promoted from lower to higher post, his pay is fixed with reference to the pay drawn by him in the lower post under FR 22(1)(A)(1) and he is likely to get more pay than a direct appointed whose pay is fixed under different set of rules, for example a UDC on promotion to the post of Assistant, get his pay fixed under FR22(1)(a)(i) with reference to the pay drawn in the UDC scale whereas the pay of the Assistant(directly recruited) is fixed normally at the minimum under rule 22-B (2). In such cases the senior direct recruit cannot claim pay parity with the junior promoted from a lower post to a higher post as seniority alone is not a criteria for allowing stepping up of Pay.

Details of the officer promoted to the grade of Tax Assistant and presently working as a Tax Assistant in Customs Division, Dhubri is given in the format below-
