Please refer to the Order No. 02/2017-2018 dated 18.12.2017 passed by the First Appellate Authority/ Joint Commissioner, Customs(Preventive) NER, Shillong has been received by this office on 21.12.2017.

In terms of para-2 at point No. 3 in Discussion and Findings of the aforesaid Order, the information on Trade Export/Import data pertaining to the LCSS under the Customs Division, Dhubri within the state of Meghalaya bordering Bangladesh for the period w.e.f. 2003-04 to 2017-18(upto November' 17) as available in the Divisional office are enclosed.

It is pertinent to be mentioned here that the Customs Division, Dhubri was formed in 1st November,2002. Thus, the data for the period 2000-01 to 2002-03 are not available in the Divisional office.
