2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
3. The successful bidder has to deposit 25% of the Bid Amount as 'Earnest Money' immediately within 24 hrs after completion of the auction. The 'Earnest Money' of the person(s) withdrawing/cancelling their offer after submitting their bid shall stand forfeited.

The successful bidder will have to deposit the full amount of auction money by way of Demand Draft at SBI, Main Branch, Shillong through TR-6 Challan within 05 (five) days from the date of confirmation/approval of the bid. The goods sold should be removed immediately once the final payment is made.


