Subject: Information under RTI Act, 2005-Reg.

Please refer to your RTI application dated 28.12.2017 as transferred from the other Public Authority on 25.01.2018 and subsequently received by this office on 07.02.2018.

The requisite information on time limit for disposal off a file on Tax Arrear Recovery (TAR) by the officers ranked from the Inspector to the Commissioner level may be referred from the following instructions/Circulars/Manual viz.

1. Central Excise Instruction No. 04/2008 dated 24.12.2008
2. Public Notice- No.02/2017 dated 08.3.2017 issued by the Commissioner ,Central , Excise, Shillong
3. Draft Arrear Recovery Manual for Central Excise, Customs & Service Tax.
4. Circular No. 1053/02/2017-CX dated 10.03.2017 issued by the CBEC,New Delhi.
5. CBEC Manual of supplementary instructions on Central Excise and Customs .

Further, the Tax Arrear Recovery is a vast matter having different aspects in terms of different legal issues and forums involved for recoverable and non-recoverable arrears. Thus, it is difficult to say specific time limit for disposal off each and every arrear related file by the officers ranked from the Inspector to the Commissioner of Central Board of Excise & Customs. Because, legal complexity involved in different arrear cases are different accordingly time taken to dispose it off varies from one file to another. However, the documents referred above inter-alia specify time limit for disposing different arrear related issues.
