It is hereby notified that the under mentioned goods will be sold in Auction through sealed Tender in the Office of the Assistant Commissioner, Customs Division, Aizawl.

#### Terms and conditions:

- Each intending bidder should produce a valid identification certificate to prove his permanent address. Copy of any of the following will be accepted as identity proof.  
a) Identity card issued by the Election Commission of India (b) Driving license (c) Passport (d) Ration card (e) ADHAAR. Those who fail to produce the identity certificate as above will not be allowed to participate in the sale.
- The intending bidder must deposit **caution money of Rs 20,000/-** (Rupees twenty thousand) only on or before 04.04.2018 latest by 1300 hrs.
- The Caution Money Deposit of the unsuccessful bidders will be returned after the sale is over on proper acknowledgement. The successful bidder will have to deposit 25% of the bid amount as **Earnest Money immediately after the auction is over. If the bidder fails to deposit Earnest Money within 24 hrs, the caution money of Rs 20,000/- stands forfeited.** The remaining bid amount should be deposited in full at the State Bank of India, Main branch, Aizawl through TR-6 Challan within 12 days from the date of confirmation/approval of the bid failing which the money already deposited i.e (caution money and Earnest Money) will be forfeited and the Sandalwood Oil will be resold through auction at the risk and loss of the defaulting bidder. The defaulting bidder will be **permanently black listed** and will not be allowed to participate in any auction in future. The goods sold should be removed immediately once the final payment is made.
- The Departmental Auction Committee reserves the right of fixing the Reserve Price of the goods being sold. The goods will be sold to the highest bidder among the bids received through sealed tenders provided the highest bid is equal to or more than the Reserve Price.
- No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
- The offer through sealed tenders should be in prescribed format addressed to **the Deputy Commissioner, Customs Division, Chanmari-Ramhlun Road, Aizawl** and should reach this office on or before **04.04.2018 (latest by 1300 hrs)**. Sealed Tenders received after due date and time and also defective/ incomplete tender forms will be summarily rejected.

- The sealed Tenders will be opened by the members of Departmental Auction Committee at the venue and time given below:

- If the date fixed for the tender cum auction happens to be holiday or general strike, the tender cum auction will be conducted on the next working day at the appointed time and place.
- The tender forms will be available in the disposal branch, Customs Division, Aizawl during office hours between 1130 hrs to 1700 hrs and will be closed on **04.04.2018 at 1300 hrs.**

11. Goods may be inspected by the intending bidders from 29.03.18 to 04.04.2018 (till 1300hrs) during office hours between 1130 hrs to 1700hrs on payment of inspection fee of Rs 50/- (Rupees fifty) only per inspection.

12. The sale will be confirmed by the competent authority who reserves the right to accept or reject any offer without assigning any reasons thereof.


