## ACTION HISTORY OF RTI REQUEST No.CCCEC/R/2018/50007

**Text of Application**

1. Rajesh Lapang filed a refund application on 22nd December 2017 before the Ld. Assistant Commissioner of Customs, office of the Commissioner of Customs (Preventive), N.E.R. Shillong for refund of sale proceeds of seized goods amounting to Rs 66,51,140.00 arising out of the Order in Appeal dated 01.12.2017, passed by the Ld. Tribunal (CESTAT), Kolkata. Goods (Betel nut 34960 KG) was seized by the Hqrs. Customs Preventive, Shillong, vide case No 11/CL/IMP/CUS/HQES.PREV/SH/15-16 dated 15.01.2016 and the Ld. Tribunal has set aside the order of confiscation and allowed the Appeal. 2. It is over 3 months, refund has not been sanctioned, whether interest would be paid. 3. Whether refund can be held back on the ground that an Appeal before the High Court is contemplated contrary to the direction contained in CBEC Circular.
