**Subject: Points of Entry for Import of plants/plant materials and other articles -reg**

Attention is brought to this office Instruction No. 01/2018 dated 05.02.2018 by which the authorised customs stations for import of plants/plant materials/plant products in this Commissionerate were listed.

Now consequent to the issue of the "Plant Quarantine (Regulation of Import into India)(Ninth Amendment) Order 2018 vide Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation & Farmers Welfare's Notification dated 18.12.18, the following Land Customs Stations in this Commissionerate are also authorised for import of plants/plant materials/plant products:

Land Customs Stations	
1	Hatar (Assam)
2	Darranga (Assam)

In view of the same, import of plants/plant materials/plant products may be allowed through the above mentioned Land Customs Stations subject to Plant Quarantine requirements. It may also be noted that the Customs clearance procedure for import consignments of commodities which require clearance by other regulatory agencies has been provided by this office Facility No. 05/2018 dated 30.10.2018, which may be adopted if required.
