#### Terms and Conditions: -

1. The Department reserves the right to fix the reserve price for the goods put up for sale through auction and also the right to withdraw or cancel the Auction if considered necessary without assigning any reasons.
2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
3. The bidder has to deposit 10% of the Bid Amount as 'Earnest Money' in the form of Demand Draft payable to the **Assistant Commissioner, Customs Division, Guwahati** immediately at the time of submission of sealed tender. The Earnest Money will not be adjusted in the sale amount accepted by the Department and shall be released only after successful completion of the sale process. Earnest Money of the person(s) rescinding their offer, withdrawing or abrogating after submitting their bid shall stand forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (i.e. 2<sup>nd</sup> highest bidder) to complete the bid provided he/ she is prepared to accept the price offered by the highest tenderer. In case of any dispute, decision of the Assistant Commissioner, Customs Division, Guwahati shall be final.
4. The successful bidder will have to deposit the full amount of Auction Money at State Bank of India, Dispur / Guwahati through T.R.6 Challan within 2 days from the date of confirmation/approval of the bid.
5. The offer through sealed tender in prescribed format addressed to the Assistant Commissioner, Customs Division, Guwahati should reach this office or be dropped in the 'Tender Box' of the

Disposal Unit, Customs Division, Guwahati – 781005 on or before 14.00 Hr 22/01/2019. Tenders received after due date shall be summarily rejected.

6. Tender for Auction No. 06/AUC/DISP/ACG/2018-19 should be superscripted on the body of the sealed envelope.
7. The sealed tenders will be opened on 22/01/2019 (after 15.00 Hr) in the presence of the Assistant Commissioner, Customs Division, Guwahati.
8. If desired, the tenderer may be present at the venue when the sealed tenders are opened.
9. In case of a tie between two or more highest bidders, a tie breaking auction will be arranged between the highest bidders immediately on the spot, to be submitted in sealed envelope. The auctioned lot will be sold to the highest bidder in the tie breaking bid.
10. The goods may be inspected by the intending tenderer during office hours.
11. The sold goods shall be removed by the successful bidder at his own expense within 72 hours of depositing the sale amount at the Bank. No assistance in respect of transportation of the sold goods will be provided by the Department.
12. The Assistant Commissioner, Customs Division, Guwahati reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
13. Disputes, if any shall be subject to the Jurisdiction in the Court of Kamrup (Metro) only.
