- 1. The Department reserves the right to fix the reserve price for the goods put up for sale through auction and also the right to withdraw or cancel the Auction if considered necessary without assigning any reasons.
- 2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
- 3. The bidder has to deposit 10% of the Bid Amount as 'Earnest Money' in the form of Demand Draft payable to the Assistant Commissioner, Customs Division, Guwahati immediately at the time of submission of sealed tender. The Earnest Money will not be adjusted in the sale amount accepted by the Department and shall be released only after successful completion of the sale process. Earnest Money of the person(s) rescinding their offer, withdrawing or abrogating after submitting their bid shall stand forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (i.e. 2nd highest bidder) to complete the bid provided he/ she is prepared to accept the price offered by the highest tenderer. In case of any dispute, decision of the Assistant Commissioner, Customs Division, Guwahati shall be final.
- 4. The successful bidder will have to deposit the full amount of Auction Money at State Bank of India, Dispur / Guwahati through T.R.6 Challan within 2 days from the date of confirmation/approval of
