**B. Time Schedule**

- The vehicles can be inspected between 11:00 am and 5.00 pm on all working days.
- Closing date & time for receipt of bid: 5.00 pm on 07.03.2019.
- Place for submitting bid: Tender Box kept at this Office. Separate cover for each vehicle should be prominently super scribed with the words **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE BEARING REGISTRATION NUMBER \_\_\_\_\_”**
- Bid Opening Date & Time: **08.03.2019 at 1:00 pm.**
- Place of Bid Opening: In the Conference Room of O/o the Commissioner of Customs (P), N.E.R., Shillong.

**Note:**

- The bidder shall deposit Earnest Money Deposit (EMD) of Rs. 5,000/- (Rupees Five Thousand only) by Cash. Bids without Earnest Money Deposit (EMD) will NOT be considered. In case, the successful bidder fails to deposit the bid amount within the stipulated period of time or on surrendering, the said EMD amount will be forfeited.
- In the event of the last date being declared as a holiday/closed day, the bids will be received/opened on the next working day at the appointed time.

- (iii) Bids shall be opened on the date/time as indicated above in the presence of the bidders or their representatives who may wish to be present.
- (iv) Bids received after the specified date and time will not be considered.
- (v) The possession of vehicle(s) would hand over to the bidder who has given/quoted the highest bid/value of the vehicle(s).
- (vi) The successful bidder shall deposit the bid amount within two days from the acceptance of tender, failing which the EMD shall be forfeited. The successful bidder has to remove the vehicle at his own cost within three days of final payment, failing which resale of the vehicles will be undertaken at the risk and cost of the defaulters.
- (vii) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters Identity Card in case of individual and registration certificate in case of firms etc.).
- (viii) All taxes/levies etc. will be borne by the buyer over and above the bid price.
