Vide Notification No. 08/2019-Customs (NT) dated 06.02.2019 issued by the Central Board of Indirect Taxes and Customs (CBIC), the National Academy of Customs, Indirect Taxes and Narcotics (NACIN) has been authorised to conduct examination under Regulation 6 of the Customs Brokers Licensing Regulations, 2018. The said examination for the year 2019 shall be conducted by NACIN on 15.03.2019 at designated centres across India. In this regard Press Release has been issued in leading newspapers on 14.02.2019.
