(2) The issue of removal of restrictions placed by Bangladesh is required to be taken up with Bangladesh Government at government level and the same has been raised by this Department at Indo-Banladesh Joint Group of Customs Meeting. As the issue of removal is within the ambit of a foreign government, no further information is available at this end.

(3) No information is held at this Commissionerate.
