**TERMS AND CONDITIONS OF  
NOTICE INVITING TENDERS (NIT) FOR DISPOSAL OF  
ONE GOVERNMENT VEHICLE**

Sealed bids are invited in proforma as per Annexure for disposal of one government vehicle belonging to the Office of the Assistant Commissioner of Customs (Prev.), Customs Division, Sangakpham, Imphal, on "AS IS WHERE IS BASIS" as per details given below:-

**A. Particulars of the vehicle:**

**B. Time Schedule:**

- (i) The vehicles can be inspected between 1100 hrs and 1700 hrs on all working days.
- (ii) Closing date and time for receipt of bid: 1700 hrs of 29.05.2019.
- (iii) Place for submitting bid: Office of the Assistant Commissioner, Customs Division, Sangakpham Bazar, Opposite DAV School, Imphal East - 795010.
- (iv) Bid opening Date and Time: 30.05.2019 at 1300 hrs.
- (v) Place of bid Opening: Office chamber of the Assistant Commissioner, Customs Division, Imphal.

**Note:**

- (i) The bidder shall deposit Earnest Money Deposit (EMD) of Rs. 5,000/- (Rupees five thousand) only by cash. Bids without Earnest Money Deposit (EMD) will not be considered. In case, the successful bidder fails to deposit the bid amount within the stipulated period of time or on surrendering, the said EMD amount will be forfeited.
- (ii) In the event of the last date being declared holiday/closed day, the bids will be received/opened on the next working day at the appointed time.
- (iii) Bids shall be opened on the date/time as indicated above in the presence of the bidders or their representatives who may wish to be present.
- (iv) Bids received after the specified date and time will not be considered.
- (v) The possession of vehicle would be handed over to the bidder who has given/quoted the highest bid/value of the vehicle.

- (vi) The successful bidder shall deposit the bid amount within two days from the acceptance of tender, failing which the EMD shall be forfeited. The successful bidder shall have to remove the vehicle at his own expense within three days of final payment, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulters.
- (vii) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters ID card in case of individual and registration certificate in case of firms etc.).
- (viii) All taxes/levies etc. will be borne by the buyer over and above the bid price.
- (ix) The vehicles will be sold on "AS IS WHERE IS BASIS" and no guarantee for its worth or quality will be given by this Department.
- (x) The Assistant Commissioner, Customs Division, Imphal, reserves the right to reject any or all quotations without giving any reason.
