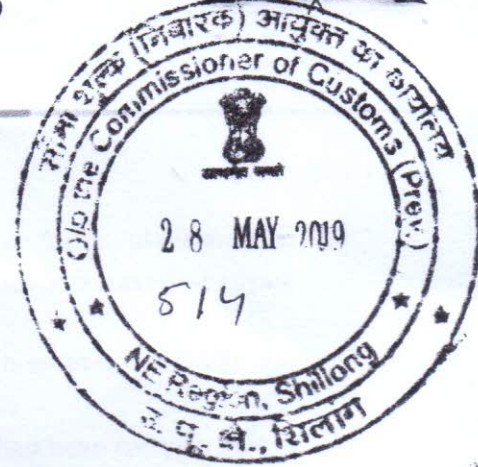

Respected Sir/Madam,

With reference to the subject cited above I have to Honour to request you to furnish/supply the following information/documents:-

1. Furnish an information whether there was an agreement between the Bhutan Government and The State of Meghalaya for transporting stone by the Bhutan stone exporter to fly thought Meghalaya road carrying the stone from Bhutan to Bangladesh via Meghalaya road.
2. Furnish the information or supply the copy of any whether your Department has given any permission or no objection certificate to the thousand of trucker of Bhutan which had been transporting the stone from Bhutan to Bangladesh via Meghalaya road.
3. Furnish the information or supply the copy of the receipt if any whether the Government of Meghalaya is collecting the taxes or revenue from the Bhutan truck Association which have been transporting the stone and other materials from Bhutan to Bangladesh via Meghalaya.
4. Supply the copy of the order the furnish the information whether Government of Meghalaya has given to the Bhutan Government or to the truck owners which are transporting stone from Bhutan to Bangladesh via Meghalaya road.
5. Furnish information which department is responsibility for grant of permission/collection of tax and issuance of no objection certificate or clearance to the thousands of trucks carrying stones from Bhutan to Bangladesh via Meghalaya road.
6. It is learned that thousands of trucks from Bhutan's are carrying stones to the neighbouring countries i.e., Bangladesh and they are passing though the road of Meghalaya so kindly furnish the information or supply the copy of any that which the department are checking those trucks which are passing through Meghalaya road to Bhutan to Bangladesh.

7. Furnish information whether the government of Meghalaya has any specific rule framed to check and verify the truckers which are coming from other countries and travelling /flying through the road of Meghalaya.
8. Furnish an information whether in the absence of any rule of our own Meghalaya can the truckers or the heavy vehicles can fly through the road of Meghalaya?
9. Furnish the information since which year the truckers from Bhutan had been carrying stones to Bangladesh and travelling though the road of Meghalaya and the total amount of revenue collected by the Government of Meghalaya from Bhutan truckers till date.
10. It is admitted fact that thousands of trucks from Bhutan are carrying stones with overloading and are flying in the road of Meghalaya but these trucks are freely moving though road of Meghalaya and there is no police department, no transport department and no concerned Deputy Commissioner verifying and checking these Bhutan truck and they are moving freely therefore furnish the information whether the Government of Meghalaya from the high level had been given the permission to Bhutan truckers to moving freely in the soil of Meghalaya.
11. Furnish information with regards to any permission/clearance /No objection Certificate given to the Bhutan truckers to travel the road of Meghalaya while transporting these stone from Bhutan to Bangladesh.

The prescribe fees of Rs. 10/-(Rupees ten) is being enclosed herewith along with the application.
