



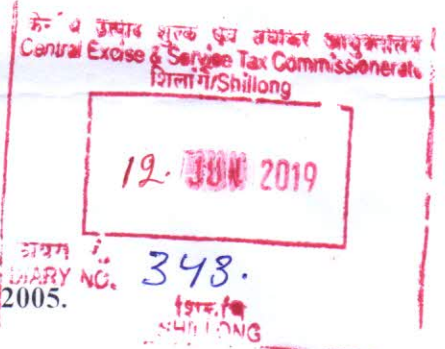

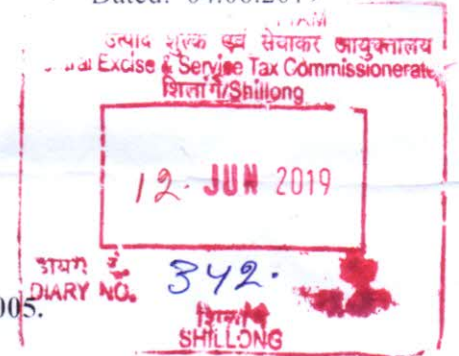

In this regard, the desired information pertaining to this Division is as below.

- A. Import. In last 5 years, only 01 case involving outright smuggling of 200 cylinders (about 16 kg each) of Refrigerant Gas of foreign origin have been registered in August 2016. In this case, the goods have been confiscated and penalty of Rs.1,00,000 have been imposed which was also recovered. The details of the accused person is Md.Allaudin, c/o Md.Iboyai, r/o Lilong Tairen Makhong, Lilong Sub-Division, PO & PS Lillong, Thoubal District, Manipur – 795130.
- B. Export. The information may be treated as Nil for the last 5 years.
