It is hereby notified for public information that the confiscated goods lying in this office will be sold in auction through Sealed Tender on 'as is where is' and 'as is what is' basis. The sale will be governed by the following 'Terms and Conditions'.

Terms and Conditions:-

1. The bid amount offered for each lot (s) is to be quoted separately, in the single Tender Form (enclosed). In other words, in the single Tender form Bidders can bid for 01 Lot or more than 01 Lot, as interested. The highest bidder for the particular LOT will win the bid for that LOT of goods. The bid is to be offered through Sealed Tender in enclosed format. The tenders can be dropped in the 'Tender Box' of this office or sent by post addressed to the undersigned at the above address, receivable till 1400 hrs of 18-11-2019. Tenders received after due date & time for whatever reasons of delay, shall not be entertained.
2. The bid is to be accompanied by 'Earnest Money' amounting to Rs. 2,000/- (two thousand) in the form of Demand Draft (payable to the Assistant Commissioner, Customs Division, Karimganj), without which the bid will not be entertained. The Earnest Money of unsuccessful bidders will be returned forthwith. The Earnest Money of the successful bidder will be returned after completion of the sale process. Earnest Money of the person(s) rescinding their offer, withdrawing or abrogating after submitting their bid shall stand forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer/bidder to complete the bid provided the price offered by the highest tenderer / bidder is acceptable to him. In case of any dispute, decision of the Assistant Commissioner, Customs Division, Karimganj shall be final. The sealed tender and the Demand Draft (Earnest Money) are to be put together in one envelope and it should be superscribed "Bid for Auction Notice No. No. 02/DISP/KXJ/2019-20".
3. The sealed tenders will be opened at 1500 hrs on 18-11-2019. If desired, the tenderer may be present at the time of opening the sealed tenders.

4. In case of a tie between two or more highest bidders, a tie breaking auction will be arranged between the highest bidders instantly on the spot, to be submitted in sealed envelope. The goods will be sold to the highest bidder in the tie breaking bid.
5. The successful bidder will have to deposit the full amount within 2 days from the date of confirmation/approval of the bid, at State Bank of India, Karimganj through TR-6 Challan.
6. After deposit of the Auction sale proceed at bank and submission of the challan, the goods will be delivered to the successful bidder. The goods are to be lifted by the successful bidder at his own expense within 48 hours of handing over.
7. Interested parties may inspect the goods on any working days during office hours, with prior intimation to the Superintendent (Disposal)/Inspector (Disposal) Customs Division, Shibbari Road, Karimganj- 788710(Telephone No. 03843 – 266709).
8. No complaint whatsoever about the condition of the sold goods will be entertained. Bidders are advised to inspect the goods and satisfy themselves.
9. The Department reserves the right to fix reserve price for the goods and also the right to withdraw, cancel or extend the last date of receiving the tenders, without assigning any reasons thereof. In that case, revised date will be notified/displayed in office Notice Board.
10. Tendering person shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
11. The bidders/tenderers shall be deemed to have read and understood all the terms & conditions of the sale and are bound by the same. Any breach of terms & conditions will lead to forfeiture of the Earnest Money.
12. The Assistant Commissioner, Customs Division, Karimganj reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
