Subject: Removing Import restrictions from the Ghasuapara LCS –reg

Attention of all concerned is invited to CBIC Notification No. 03/2020-Customs (N.T.) dated 15.01.2020 regarding the amendments in the notification of the Government of India, No. 63/94-Customs (N.T), dated 21.11.1994, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), vide number S.O. 830 (E), dated 21.11.1994.

2. The said notification has been amended by CBIC by omitting the item (ii), in the first proviso, in the opening paragraph, whereby Ghasuapara was appointed as Land Customs Station only for the purpose of exports of all goods from India.

3. Henceforth, all goods shall be permissible for export and import through Ghasuapara LCS unless there are specific prohibition/ restriction pertaining to such goods.
