### **Terms and Conditions:-**

- The bid is to be offered through Sealed Tender (in enclosed format) and dropped in the 'Tender Box'
  of this office or submitted by post addressed to the Assistant Commissioner, Customs Division,
  Shibbari Road, Karimganj receivable till 1400 hrs of 25-03-2020. Tenders received after due date &
  time for whatever reasons of delay, shall not be entertained.
- 2. The bid is to be accompanied by an 'Earnest Money' in the form of Demand Draft (payable to the Assistant Commissioner, Customs Division, Karimganj), without which the bid will not be entertained. The amount of 'Earnest Money' will be 10% of the bid amount offered by the bidder. The Earnest Money of unsuccessful bidders will be returned forthwith. The Earnest Money of the successful bidder will be returned after completion of the sale process. Earnest Money of the person(s) rescinding their offer, withdrawing or abrogating after submitting their bid shall stand forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer/bidder to complete the bid provided the price offered by the highest tenderer/bidder is acceptable to him. In case of any dispute, decision of the Assistant Commissioner, Customs Division, Karimganj shall be final.
- 3. The sealed tender and the Demand Draft (Earnest Money) are to be put together in one envelope and it should be superscribed "Bid for Auction Notice No. 01/DPF/2019-20".
- 4. The sealed tenders will be opened at 1500 hrs on 25-03-2020. If desired, the tenderer may be present at the time of opening the sealed tenders.
- 5. In case of a tie between two or more highest bidders, a tie breaking auction will be arranged between the highest bidders instantly on the spot, to be submitted in sealed envelope. The auctioned vehicle will be sold to the highest bidder in the tie breaking bid.

- 6. The successful bidder will have to deposit the full amount of Auction Money within 2 days from the date of confirmation/approval of the bid, at State Bank of India, Karimganj through TR-6 Challan.
- After deposit of the Auction sale proceed at bank and submission of the challan, the vehicle will be handed over the successful bidder at the spot where it is. The vehicle should be removed by the successful bidder at his own expense within 72 hours of handing over.

- 9. No complaint whatsoever about the condition of the sold vehicle will be entertained. Bidders are advised to inspect the vehicle and satisfy themselves about the condition.
- 10. The Department reserves the right to fix reserve price for the said vehicle and also the right to withdraw, cancel or extend the last date of receiving the tenders, without assigning any reasons thereof. In that case revised date will be notified and displayed in office Notice Board.
- 11. Tendering person shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
- 12. The bidders/tenderers shall be deemed to have read and understood all the terms & conditions of the sale and are bound by the same. Any breach of terms & conditions will lead to forfeiture of the Earnest Money.
