Subject : Turant Customs – Setting up of Turant Suvidra Kendras (TSKs) under Guwahati Customs Division.

Attention of all concerned is invited to CBIC's Circular No. 32/2020-Customs dated 06.07.2020 wherein Board has decided to extend Turant Suvidha Kendras (TSKs) to all the Customs formations for carrying out the functions mentioned in para 5 of Circular No. 28/2020-Customs dated 05.06.2020 read with Instruction No. 09/2020-Customs dated 05.06.2020 providing details of the roles and functions of TSKs.

2. Para 3.1 of of Board's Circular No. 32/2020-Customs dated 06.07.2020 provides for setting up of TSKs in all Customs stations. As such, it has been decided to set up Turant Suvidha Kendras comprising of the following officers at all EDI locations under Guwahati Customs Division with the objective to facilitate the trade in completing various formalities relating to the Customs Assessment at the port of import as under:

3. Trade may approach the said Turant Suvidha Kendras during working hours for the following purposes:

- (i) Accept Bond or Bank Guarantee.
- (ii) Carry out any other verification required for assessment.
- (iii) Defacing of documents/permits/licences, whenever required.
- (iv) Debit of documents/permits/licences, whenever required.
- (v) Other functions determined by Commissioner to facilitate trade.

4. Difficulty, if any, faced in its implementation may be brought to the notice of this office.
