Terms & Conditions:-

- 1. The officer supervising the auction reserves to himself the right of fixing 'Reserve Price' for the goods, put up for sale through auction and of withdrawing part or whole of the goods from the auction, if considered necessary by him, without assigning any reason.
- 2. The goods will be sold to the highest bidder among the bids received through sealed tenders, provided the highest bid is equal to or more than the 'Reserve Price'.
- 3. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
- 4. The successful bidder has to deposit 25% of the Bid Amount as 'Earnest Money' immediately within 24 hrs after completion of the auction. The 'Earnest Money' of the person(s) withdrawing/cancelling their offer after submitting their bid shall stand forfeited.
