



### Terms & Conditions:-

- The officer supervising the auction reserves to himself the right of fixing 'Reserve Price'
  for the goods, put up for sale through auction and of withdrawing part or whole of the
  goods from the auction, if considered necessary by him, without assigning any reason.
- 2. The goods will be sold to the highest bidder among the bids received provided the highest bid is equal to or more than the 'Reserve Price'.
- No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
- 4. The offer through sealed tenders in prescribed format addressed to the Deputy Commissioner, O/o the Commissioner (Preventive), N.E.R., 110 Mahatma Gandhi Road, Shillong-793001 should reach this office or to be dropped in the 'Tender Box' of this Office latest by 10.11.2020 (before 2:00 P.M.). Sealed tenders received after due date and time will be summarily rejected.
- 5. "Tender for Auction Notice No. 05/2020" and "Sealed tender for lot no." should be super-scribed on the body of the sealed envelope.

If desired, the tenderers may be present at the venue when the sealed tenders are opened.

7. All participating bidders/ tenderers must deposit Caution Money Rs. 2500/(Rupees Two thousand five hundred only) for Lot 1 and 1000/- (Rupees One
thousand only) for Lot 2 in cash and get registered with Supdt(Disposal) after
furnishing all the relevant information, including telephone no, PAN etc. Only
Registered bidders wil be allowed to inspect the lots and bid in the auction. The
caution money will be adjusted against the earnest money or refunded, as the
case may be, at the conclusion of the auction. If the highest bidder fails to deposit
Earnest Money immediately after auction, the caution money shall be forfeited to
Government.

- 8. Highest bidder has to deposit 25% of sale value as Earnest Money immediately after auction and the balance amount shall be paid within 48 hours, failing which the sale shall be treated as cancelled and the earnest money shall be forfeited to Government; and the goods shall be resold.
