It is hereby notified for Public information that **1831 Kg** of Poppy Seeds and **995 Kg** of Areca Nuts will be sold in Auction on "AS IS WHERE IS BASIS" through Auction-cum-Sealed Tender at the Office of the Deputy Commissioner of Guwahati Customs Division, Nilamoni Phukan Path, Christian Basti, Guwahati, Assam-781005.

#### **Terms and Conditions: -**

1. The Department reserves the right to fix the reserve price for the goods put up for sale through auction and also the right to withdraw or cancel the Auction if considered necessary without assigning any reasons.
2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
3. The successful bidder has to deposit 10% of the Bid Amount as 'Earnest Money' in the form of **Demand Draft** payable to the **Deputy Commissioner, Customs Division, Guwahati** along with the tender. The Earnest Money will not be adjusted in the sale amount accepted by the Department and shall be released only after successful completion of the sale process. Earnest Money of the person(s) rescinding their offer, withdrawing or abrogating after submitting their bid shall stand forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (i.e. 2<sup>nd</sup> highest bidder) to complete the bid provided he/ she is prepared to accept the price offered by the highest tenderer. In case of any dispute, decision of the Deputy Commissioner, Customs Division, Guwahati shall be final.
4. The offer through sealed tender in prescribed format addressed to the Deputy Commissioner, Customs Division, Guwahati should reach this office or to be dropped in the 'Tender Box' of Disposal Unit, Customs Division, Guwahati – 781005. Tenders received after due date will be summarily rejected.
5. The successful bidder will have to deposit the full amount of Auction Money at State Bank of India, Dispur / Guwahati through T.R.6 challan within 5 days from the date of confirmation/ approval of the bid.
6. Tender for Auction No. **01/AUC/DISP/ACG/2022-23** should be super scribed on the body of the sealed envelope.
7. The sealed tenders will be opened at **11 AM on 18.10.2022** in the presence of the Deputy Commissioner, Customs Division, Guwahati.
