

## Establishment Order No. 32/2022 Dated: Shillong, the 19<sup>th</sup> December, 2022.

In supersession of this Office's Estt. Order No. 27/2022 dated the 24<sup>th</sup> August, 2022, I, the undersigned, as Head of Department, hereby declare Shri Thomas Basumatary, Joint Commissioner, Customs (Prev.) N.E.R., Shillong as the <u>"Head of Office" of Customs Hqrs., Shillong</u> under Rule 14 of Delegation of Financial Power Rules, 1978 and also delegate and authorize him to exercise the Financial powers vested in the Head of the Department under Rule 13 (1) and 13 (2) of the said Rules to Shri Thomas Basumatary, Joint Commissioner as appended herewith in Annexure I, with immediate effect and till further orders.

- 2. Controlling Officer for sanctioning, signing, countersigning of bills in the form of HBA, Computer Advance, Pay Fixation matters, all GPF related matters <u>in respect of Group 'B' & Group 'C'</u> officers.
- Controlling Officer for sanctioning, signing, countersigning of bills in the form of TA, TTA, LTC, Medical Bills, OTA, HBA, Medical Bills, all GPF-related matters, sanction of dues in respect of pension/family pension cases, CEA, Uniform allowances, etc in respect of Group 'B' (Gazetted) Officers.
- 4. Sanctioning Authority for all kinds of Leave under Rule 3(1)(c)(1) of CCS (Leave) Rules, 1972 in respect of Group 'B' (Gazetted) Officers except for Extra Ordinary Leave and Spl. Casual Leave which will be sanctioned by the Head of Department.
- 5. The Chief Accounts Officer, Customs Hqrs., Shillong will continue to retain the powers conferred upon him vide Estt. Order No. 17/2021 dated 01.07.2021 and Estt. Order No. 18/2022 dated 05.05.2021.

1. The various austerity instructions issued by the government and other item wise general instructions as issued from time to time by CBIC and other competent authorities, shall also apply while exercising the delegated powers stated above against each respective item.

- 2. The General Financial Rules, 2017 (effective from 01.04.2017) and the delegation of Financial Power Rules, 1978 as amended time to time shall apply in respect of each of these stated items.
- 3. The above powers are to be exercised subject to fiscal codes and procedures and limits being within the budgetary allocation.
- 4. No sanction is to be accorded in exercise of the above delegation in excess of the available budget grant of the concerned object head. Also, while exercising such powers, austerity instruction of the government should be kept in mind.

This order shall come into effect from the date of issue of this order.
