**Subject: Appointment of Custodian for import and export cargo and Customs Cargo Service Provider at Inland Container Depot (ICD), Amingaon – Renewal thereof.**

In exercise of the powers conferred under Section 45(1) and 141(2) of the Customs Act, 1962, the appointment of Container Corporation of India Ltd. (hereinafter referred as "CONCOR") located at Amingaon, Guwahati, Assam – 31 and having Registered Office at CONCOR Bhawan, C-3, Mathura Road, Opp. Apollo Hospital, New Delhi- 110 076 and Eastern Regional Office at Metro Rail Bhavan, 10<sup>th</sup> Floor, 33/1, J.L. Nehru Road, Kolkata- 700 071 is hereby renewed for a further period of five years (05) from 23.06.2022 in respect of the following:

- (i) As Custodian of imported goods received at the Inland Container Depot (ICD), Amingaon, Guwahati until those goods are cleared for home consumption or warehoused or transhipped in accordance with the provisions of Chapter-VIII of the Customs Act, 1962.
- (ii) As Custodian of export cargo brought into the ICD, Amingaon, Guwahati, Assam for stuffing, accountal, Customs examination, transportation and safe delivery of the Cargo for onward shipment

And, in exercise of the power conferred under Regulation 10 and Regulation 13 of the "Handling of Cargo in Customs Areas Regulations, 2009", the application by CONCOR to work as "Customs Cargo Services Provider" for ICD, Amingaon, Guwahati, Assam- 31 is hereby renewed for a further period of five years (05) from 23.06.2022 subject to the following conditions:

- (i) The Custodian M/s Container Corporation of India Ltd. approved as " Customs Cargo Services Provider" for the said ICD shall abide by all the provisions of the Customs Act, 1962 and the rules under the "Handling of Cargo in Customs Areas Regulations, 2009" and other regulations, notifications, orders made/ issued there under.
- (ii) The duration of appointment of M/s Container Corporation of India Ltd. as

'Custodian' and as 'Customs Cargo Services Provider' shall remain valid for a period of 05 (five) years from 23.06.2022 unless otherwise suspended/revoked/cancelled prior to the expiry of the said period.

- (iii) The Commissioner of Customs (P), NER, Shillong shall have the Right to review the approval as 'Customs Cargo Services Provider' before the completion of five years for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009" or as per the directions of the Government of India.
