It is hereby notified that the under mentioned seized goods will be sold in public auction in the Office of the undersigned on **01.05.2023 at 11.00 a.m.**

The Departmental auction committee reserves the right of fixing the reserved price for goods for selling the same in smaller or whole lot or withdrawing a part of the whole lot from auction without assigning any reason thereof. In case of dispute with regard to the bid, the goods may be put in auction again at the discretion of the Supervising Officer. No complaint from the buyers or to the quantity or quality of the goods will be entertained after the goods are sold.

The supervising authority shall ask to his discretion a reasonable caution money from the intending bidders before the auction starts. In case of successful bidding, the caution money will be adjusted against the bid money, otherwise the same will be refunded at the spot. Goods once knocked down or registered in the name of the highest bidder cannot be transferred to any other name and should be removed immediately.

The successful bidder shall have to deposit the full amount of the bid money immediately with the Officer conducting the auction, failing which the goods will be resold in any manner which the supervising Officer thinks fit and proper.

The goods are offered for auction at Tinsukia as is where is basis and the intending bidder can inspect the goods before commencement of auction between 10.00 hrs to 12.00 hrs. on 29.04.2023.

The successful bidder may have to pay an incidental charge which will be declared before the auction commences.
