Subject: Appointment of Custodian for import and export cargo at Dawki Land Customs Station; Integrated Check Post (ICP), Dawki, Meghalaya — reg.

In exercise of the powers conferred under Section 45(1) of the Customs Act, 1962 read with the provisions of the Handling of Cargo in Customs Areas Regulations, 2009, **Land Port Authority of India (A Govt. of India Undertaking),** having *Hqrs. office at Lok Nayak Bhawan, Ist Floor, Khan Market, New Delhi —110003* is hereby appointed as the *Custodian of imported goods received in the Land Customs Station; Integrated Check Post, Dawki, Meghalaya* until those goods are cleared for home consumption or warehoused or transshipped in accordance with the provision of Chapter— VIII of the Customs Act, 1962. Similarly, Land Port Authority of India will also be the *Custodian of export cargo brought in the Land Customs Station; Integrated Check Post, Dawki Meghalaya* for stuffing, accountal, Customs examination, transportation and for the safe delivery of the Cargo of onward shipment.

Land Port Authority of India (A Govt. of India Undertaking), having Hqrs. office at Lok Nayak Bhawan, 1<sup>st</sup> Floor, Khan Market, New Delhi — 110003, as Custodian of goods meant for export and import would be required to comply with the relevant provisions of Section 45(2) of the Customs Act, 1962, the provision of Handling of Cargo in Customs Areas Regulation, 2009 and Rules, Regulations and instructions issued from time to time under the Customs Act, 1962.
