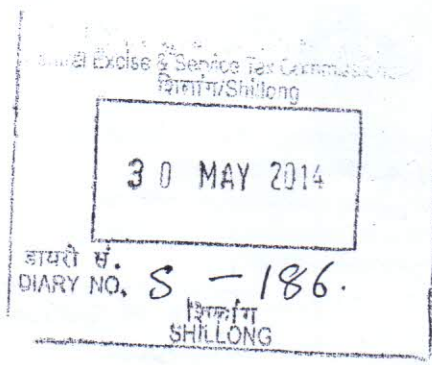

For the period from 2012-2013 to April 2014.


c) Specific details of information required
