3(2). No retired Gr. B & C officers under the Customs Division, Dhubri has been paid gratuity during last ten years where disciplinary/judicial proceedings were pending.

3(3) Commutation of value of pension has not been paid to such officers during last 10 years against whom disciplinary/judicial proceedings were pending on the date of payment.


