5. Tenders for items of lower configuration than are specified above will summarily be rejected.
6. Tender should be signed by the authorised person and his full name and status should be indicated below his signature.
7. Payment against Bill / Invoice shall be released only after installation of Cameras in good & working conditions.
8. Tender shall be opened by Purchase Committee on the next working day. Party may send their representative to be present when the tender is opened, if it so desires.
