### Public Notice No. 04/2013

Dated, Shillong the 6<sup>th</sup> September, 2013.

Subject:- Customs Broker's Examination under CBLR, 2013

As an exercise for the convenience of the trade and public, this is for the information of all concerned that Customs Brokers Licensing Regulations, 2013 (referred to as "CBLR, 2013" herein after) have come into effect from 21-06-2013. The Customs House Agents Licensing Regulations, 2004 (referred to as "CHALR, 2004" herein after) are no longer in force and, hence, examination for Customs Brokers license cannot be held under these regulations. Sub-Regulation 1 of Regulation 4 of CBLR, 2013 prescribes that DGICCE shall in the month of April every year invite applications for conducting examination and subsequent grant of license to act as Customs Broker. Sub-Regulation 2 of Regulation 6 *ibid.* prescribes that the written examination shall be conducted on specified dates in the month of January of each year. DGICCE shall issue advertisement in newspapers for January, 2014 Customs Brokers license written examination accordingly. Further, applications already received for CHA license under CHALR, 2004 cannot be considered as applications for Customs Broker license received under CBLR, 2013.

It is notified that the applications for CHA license received under CHALR, 2004 shall stand withdrawn. The applicants are, therefore, advised to apply afresh for Customs Broker license under CBLR, 2013 as per advertisement to be issued by DGICCE.
