Subject: Working hours and weekly holiday at Land Customs Stations on the India-Bangladesh border and return of trucks- Golakganj and Mankachar LCs-reg

The trade and concerned public are hereby informed that in pursuance of the decisions taken in the Bangladesh-India 5<sup>th</sup> Joint Group of Customs (JGoC) Commissioner level (Team-1) meeting held at Shillong on 16-17 December, 2016, working hours and days of weekly closure of the Golakganj and Mankachar Land Customs Stations in this Commissionerate have been decided.

The agreed upon timings and day of weekly closure are as given in Table below:
