**Subject:** Declaration of Sonamura, Jogigopha and Badarpur 'Port of Call/ Extended Port of Call' under PIWT&T as Customs notified port – reg.

The Trade and all concerned are hereby informed that consequent to the mutually agreed upon decision taken in the 2<sup>nd</sup> Addendum to "Protocol on Inland Water Transit and Trade" (PIWT&T) between India and Bangladesh held on 20<sup>th</sup> May, 2020, it has been decided to add 2 (two) 'Ports of Call' namely '**Sonamura**' and '**Jogigopha**' in addition to 4 (four) existing 'Ports of Call' (Karimganj, Pandu, Shilghat and Dhubri) and 1 (one) 'Extended Port of Call' namely '**Badarpur**' in this Commissionerate.

2. As a result, the term 'route' mentioned in Article 1.2 of the Protocol on Inland Water Transit and Trade, henceforth shall be as follows:
