Approved loading and unloading place and limits of Customs Area in Srimantapur (Sonamura) – reg.

In view of the Sonamura being declared as Port of Call vide 2<sup>nd</sup> Addendum dated 20.05.2020 to the Protocol on Inland Transit and Trade (PIWT&T) between India and Bangladesh, the Commissioner of Customs (Preventive), NER, Shillong by virtue of power vested under Sub-section (a) of Section 8 of the Customs Act, 1962 (52 of 1962), hereby approves Port of Call, Sonamura located along the river Gomati as a Place of Loading of export cargo and Unloading of import cargo exported / imported through Land Customs Station, Srimantapur which falls within the 'Customs Areas' of Srimantapur LCS notified under Sub-Section (a) of Section 8 of Customs Act, 1962 vide Facility Nos. 08/2010 dated 01.12.2010 and 05/2016 dated 16.09.2016 subject to the strict observance of relevant provisions of the Customs Act, 1962 and other instructions issued in this regard by the Government of India or the Commissioner of Customs, as the case may be, from time to time.

Provided that the said premises shall remain in complete control of Land Customs Station, Srimantapur and that sealing of containers and loading/unloading of export/import cargo is done under the supervision of proper Customs officer.
