Subject: Notification of Border Haats Bholaganj, Nalikata and Ryingku & Land Customs Stations Jogighopa and Badarpur –reg

Attention of all concerned is invited to CBIC Notification No. 111/2020-Customs (N.T.) dated 11.12.2020 regarding the amendments in the notification of the Government of India, No. 63/94-Customs (N.T), dated 21.11.1994, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), vide number S.O. 830 (E), dated 21.11.1994.

2. The said notification has been amended by CBIC by substituting words “Balat, Kalaichar, Srinagar, Kamalasagar, Bholaganj, Nalikata and Ryingku” for “Balat, Kalaichar, Srinagar and Kamalasagar” in item (i)(a), in the fourth proviso, in the opening paragraph. Thereby ‘Bholaganj’ and ‘Ryingku’ have been notified as Border Haats along with the pre-existing formation as Land Customs Stations and ‘Nalikata’ has been notified as a new Border Haat with the following additional/new routes:

3. The said Notification No. 63/94-Customs (N.T), dated 21.11.1994 has been further amended by inserting items (60) and (61) in column (3) and corresponding entries relating thereto in column (4) against serial number 2 relating to land frontier of Bangladesh. Thereby, 'Jogighopa' and 'Badarpur' under the jurisdiction of this Commissionerate have been notified as Land Customs Stations under Section 7(b) and 7(c) of Customs Act, 1962. Declared routes of the new notified Land Customs Station shall be as follows:

4. Therefore, all goods shall be permissible for export and import through Jogighopa and Badarpur LCSs unless there are specific prohibition/ restriction pertaining to such goods.
